

## MODIFICATION ACT N° 1 TO THE REQUEST FOR INFORMATION TO SUPPLIERS - RFI MONÓMEROS - 001 OF 2023. (MARKET STUDY - INVITATION TO QUOTE)

The company Monómeros Colombo Venezolanos S.A., in development of the Request for Information to Suppliers - RFI Monómeros 001 - 2023, published on October 25, 2023, in order to build the terms and conditions of the International Public Tender process to be contracted for the "Supply of technology for secondary abatement of nitrous oxide ( $N_2O$ ), for the nitric acid plant of Monómeros, located in the Special, Industrial and Port District of Barranquilla, Department of Atlántico - Colombia, in the context of the Nitric Acid Climate Action Group (NACAG) initiative", informs that:

In order to guarantee the objective of the market research and in attention to the completion of the activities related to the "final date to submit comments and questions to the SIP-Request for Information to Suppliers "Invitation to Quote" and to the consultations about the supply, related in Annex 2" it considers necessary, to make some clarifications and modifications to the market research as follows:

**ADJUSTMENT N° 1: MODIFY item VI "Guarantees"** of the Request for Information to Suppliers - RFI, regarding the percentage of the Compliance and/or Bank Policy coverage to be contemplated by the Suppliers Interested in participating in this market research, which shall read as follows:

Guarantee	Percentage
	For <b>ten percent (10%)</b> of the total value of the supply contract to be signed with the awarded supplier, valid for the total term of the contract and two (2) more months.
Compliance	The awarded supplier must present in favor of Monómeros Colombo Venezolanos S.A., a guarantee that will ensure the fulfilment of the obligations arising from the signing of the contract and that will cover the company from the direct damages derived from the total or partial nonfulfilment of the obligations, as well as from its late or defective fulfilment, when they are attributable to the future contractor.



In addition to these risks, this cover shall always include the payment of the value of the fines and the penalty clause agreed in the contract.
This guarantee is a prerequisite for starting the execution of the activities and obligations defined in the contract.

**ADJUSTMENT N° 2: MODIFY question N° 9 of Annex 2** "Quotation and supply inquiry form", which will read as follows:

"(...) 9. According to your experience, which of the goods, services and technical specifications listed in Annex 1A, could not be supplied by the company you represent?

The other terms and conditions of the Supplier Information Request (RFI) and especially the activities, dates and conditions for the required supply that have not been modified through this document, **continue to apply as initially foreseen.** 

All interested parties must fill out and send to Monómeros the Annexes attached to this request for Information to Suppliers, where the items to be quoted and the minimum characteristics or specifications of the goods and services to be contracted are detailed. All the fields must be filled in, including those related to the contact information of the quoted, and sent to Monómeros through the e-mail <a href="mailto:licitacionabatimiento@monomeros.com.co">licitacionabatimiento@monomeros.com.co</a>, no later than the date established in the schedule defined in this request for Information to Suppliers.
