

COMMUNICATION TO INTERESTED BIDDERS INTERNATIONAL OPEN TENDER MONÓMEROS 001-2024

OBJECT: To contract the "Supply of a Secondary Nitrous Oxide (N₂O) Abatement System for the Nitric Acid Plant of Monómeros, located in the Special, Industrial and Port District of Barranquilla, Department of Atlántico - Colombia, in the context of the Nitric Acid Climate Action Group (NACAG) initiative".

The company Monómeros Colombo Venezolanos S.A., is pleased to inform interested suppliers that:

The expressions of interest indicated in the final bidding documents of the process were received. We wish to point out that the bidding process includes a **visit to the Monómeros nitric acid plant**, as well as the holding of a **risk allocation hearing**. Both activities are scheduled within the bidding schedule and are of vital importance to ensure a comprehensive understanding of the technical, legal and financial aspects related to the project to be executed by the supplier that is awarded the contract.

Detailed information about the on-site visit to the Monómeros plant and the risk allocation hearing will be sent to the e-mail addresses provided by each of the bidders who have expressed their interest in participating in this bid. Therefore, it is essential that you keep your email monitored to receive such information in a timely manner.

It is clarified that the on-site visit to the plant is **optional**; Suppliers may submit proposals and ask questions even without having visited the plant. The nitric acid plant reactor will be **CLOSED** during the visit, so it will not be possible to inspect the inside of the reactor. A maximum of 3 (three) representatives per Supplier will be allowed to attend the site visit.

The **virtual risk allocation hearing** seeks to provide an additional space for bidders to review the allocation of risks that were previously included by Monómeros in the document called "Risk Identification and Distribution Matrix". In this way, suppliers will be able to identify and assess the foreseeable risks of the contract, as well as designate the contractual party that will be responsible for taking measures for their prevention and mitigation. The final distribution of the risks associated with the project and the contract will be made at this hearing.



Attendance at this hearing is NOT mandatory. In any case, it is the bidder's responsibility to integrate its proposal and to obtain and analyze the information required to prepare and submit it. Therefore, what is consulted, analyzed, reported or specified during this virtual hearing will be presumed to be known and accepted by all bidders. Monómeros will take minutes of the hearing, which, once prepared, will be published on the website.
